Clubs are reminded that at the A.G.M. an overwhelming majority voted for a new implementation of rule 10 (F). Full details are available on the web site.

STEP 7 FACILITIES

The league owe a debt of thanks to Alan Friend who, despite suffering a serious illness during June, from which he has thankfully recovered, has visited several of our clubs in his role as League Development Officer, to advise them on how to bring their facilities up to the required Level 7 standard.

As a result our League are the only League in the County to have been granted provisional Step 7 status for the coming season and we should be granted full Step 7 status for season 2012-2013.

Clubs should be congratulated on the amount of work many of them have put in over the closed season to enable us to have achieved this goal which was agreed at the Special General Meeting held last season.

If any other clubs would like to avail themselves of Alan's expertise, I am sure he would be happy to pay them a visit.

F.A. INTER LEAGUE CUP

Our First Round tie against the Herts Senior County League, who beat the Middlesex County League 5 – 4 on penalties in the Preliminary Round, will take place on Saturday 08 October at A.F.C. Hornchurch K.O. 3:00 pm. Teams with players in the squad will have their League matches postponed. Your support at this match would be very much appreciated.

DO THE MATHS !!! (by the Fixtures Secretary)

The average number of Saturdays available to our clubs for home matches during the season is 32.

Clubs with teams in the top two divisions of the Senior and Reserve Sections will have at least 25 home matches to play. In addition, if they are moderately successful in the County and League Cups and play in three rounds with half the matches at home, this will add a further 6 matches to their home schedule. Last season the average number of matches postponed by each club due to the weather was 5. This makes a total of 36 Saturdays.

On this basis before the season even starts many clubs are in deficit and will be playing mid-week fixtures. The more successful that teams are in the various cup competitions, the more mid-week matches they will have to play. In addition a total of 37 Saturdays have been closed by teams so far including 29 on the 20 August.

It must be asked if it was in the best interests of the League as a whole that the A.G.M. voted to start the new season on 20 August and not allow clubs that had pitches available and wished to play, to play during the previous week, after all some clubs were playing friendlies from 16 July and will be playing friendlies on 13 August.

Clubs already complain about the fact that we play deep into May and have a large number of mid-week matches including some at the start of the season. Clubs need to ask themselves what they can do to help resolve this problem and the first thing is to make every effort to start the season earlier and not to close so many dates.

If you think this article exaggerates the problem **DO THE MATHS**.
