SATURDAY 03 DECEMBER

On Saturday 03 December **ONLY**, **ALL** postponement notification and results **MUST** be telephoned to **Phil Coulthard** on **01376 321 600** and **NOT** the normal Results Line number.

In addition, **on this one Saturday only**, you do not have to give the names of goalscorers.

PLEASE ENSURE YOU LET THE RELEVANT CLUB OFFICIALS KNOW. IF ANYONE LEAVES THE RESULT ON THE WRONG PHONE OR PHONES IT IN TO PHIL LATE, THEY WILL BE FINED.

Results will be uploaded to the Full Time web site on the Saturday with the Mitoo site been updated later. There will be no Final Whistle or match reports for this date and the results will not be available on the results line.

Any changes to fixtures on 10 December will be uploaded to the Mitoo site as soon as possible and clubs involved will be notified by e-mail.

Normal service will be resumed on the following Saturday.

POSTPONING FIXTURES

There is a full programme of fixtures during December and there are some weeks when clubs have pitches available as both their teams are away.

Should a pitch be deemed unplayable clubs are requested, before they tell their players the match is off, to contact their opponents and see if their pitch is available. If the match can be switched to the opponents pitch and the two teams have not met in the reverse fixture, then the match will become a home fixture for the original away team.

If the two teams have met in the reverse fixture then the match will remain as a home fixture for the original home team even though it is being played on the away teams ground.

If all clubs can co-operate in this we can avoid a lot of mid-week late season fixtures

ILLEGAL MARKINGS

Clubs and referees are reminded that it is against the Laws of The Game for players to scrape illegal markings on any of the lines on the pitch. Players should be cautioned if they are seen to be doing this.

It is also up to clubs to ensure that prior to the start of a match the pitch is inspected to ensure that any animal faeces is removed.
