## **FIXTURES**

Continued uncertainty regarding the fate of one of our teams, means that there may well be additional and changed fixtures to those shown within this Newsletter. The late drawing of the Essex Premier Cup Quarter Finals also means additional fixtures have yet to be arranged for 11 February. Any changes and additions will be advised in the normal way.

Rather earlier than normal due to the good weather we have been having, we have reached a situation where some teams are running out of opposition to play. Whilst the Fixtures Secretary is trying to be as even handed as possible when arranging fixtures, there will be some teams that will find themselves having no fixtures on some Saturdays. Unfortunately this does not mean that there will be no mid-week fixtures from the beginning of April as some clubs seem to be doing very well in the various cup competitions thus restricting the number of league matches they have played.

## **REGISTRATION OF PLAYERS**

Clubs should check the forthcoming fixtures on the Full Time site for a list of players who are registered with their club. Do not assume that just because you have sent a registration form to the Registration Secretary it has been received and the player has been registered.

Checking the names of players who played for reserve teams against you is also a way of ensuring that ineligible players have not played.

## **PLAYERS SIGNED ON THE DAY**

At the last Committee meeting six clubs were reported for playing ineligible players because they had signed them on on the day and the player was already registered with another club. Clubs are urged to contact the Registration Secretary to check if a player is already registered before they sign him on on the day. If the Registration Secretary is not available, you should contact the Fixtures Secretary on 01206 385 872 who is available every Saturday and who also has access to this information. If there is no answer leave a message and he will get back to you before kick-off time.

## **DISCIPLINE**

The Discipline Secretary reported at the last Management Committee meeting that so far this season **ELEVEN** managers had been reported to the County for misconduct. This is an intolerable situation and there are already a number of clubs who are perilously close to being recommended for expulsion from the league due to their misconduct and it is up to managers to set a good example.

## **NOTES FROM THE HON. SECRETARY**

### **Rule Changes**

Any clubs wishing to put forward changes to the current rules **MUST** do so in writing to the Hon. Secretary **BY 01 FEBRUARY 2012**. Proposed rule changes will then be circulated to all clubs by 15 February 2012 and any amendments to these proposals must be submitted to the Hon. Secretary by 28 February 2012. Proposed rule changes will then be sent to the Essex County F.A. for approval and those that are approved will be put to the A.G.M. in June.
