**ALL CLUBS MEETING**

Notification of the All Clubs Meeting to be held on Friday 09 January 2008 at Old Chelmsfordians will be sent out shortly.

The Football Association have announced from the start of the 2009/2010 season a Match Based Suspension System for indiscipline by players playing in matches for teams in our Premier Division will be introduced.

Mr. Mark Ives from the Football Association will be at this meeting to explain the new system and answer any questions you may have. A copy of the PowerPoint presentation on this subject is available from the League Secretary ahead of this meeting if you want it.

**RULE CHANGES AND CLUB REPRESENTATIVES**

Clubs are reminded that should they wish to propose any rule changes for the 2009/2010 season, these should be submitted to the League Hon. Secretary by 1st February 2009.

Clubs are also reminded that just because there are already the full complement of eight elected club members on the management committee this does not preclude other candidates being put up for election at the A.G.M.. The procedure for this is detailed in Rule 4 (B). This same procedure applies if anyone wants to replace one of the officers.

**NEWSLETTER & HANDBOOK INFORMATION**

Judging by the number of times the Referees Secretary has been telephoned in the past few months to find out a referees phone number that has been included in Newsletters, it is obvious that some clubs are not passing copies of the Newsletters on to club officials. This is confirmed by some clubs asking to whom they should send December fines to when this information was contained in the December Newsletter.

Will clubs please ensure that they pass copies of the Monthly Newsletter on to **all** their officers. Copies of all newsletters are available on the web site.

It is also obvious by the number of times the League Secretary has been contacted regarding matters not within his realms of responsibility, that the note advising clubs who to contact with queries shown on page 45 of the Handbook has not been read. We have also been advised that some clubs are contacting club Secretaries instead of club Fixtures Secretaries, where there is one, to confirm matches.

Can clubs please make an effort to contact the right people as not doing so can cause confusion and problems.

**CLUB E-MAIL ADDRESSES**

Some clubs still cannot be bothered to acknowledge receipt of e-mails from league officers which causes them considerable problems. It is a clubs responsibility to ensure that a working club e-mail address is available to league officers and the excuse that an e-mail has not been received is not acceptable.

If the designated e-mail address holder is away please notify the League Secretary of an alternative to be used during this period. You must also notify the League Secretary when the original recipient is available.

When sending in Referees Marks or Match Result Sheets it is recommended that you request a receipt from the league officer concerned.. Claiming that you sent the forms out in time does not mean that it arrived in time and by requesting a receipt you can easily find out if it has got lost in the ether.

Observance of the above simple requests makes the running of the league much easier for both officers and clubs.

**NOTIFICATION OF POSTPONEMENTS**

It was agreed at the December Management Committee Meeting that due to the fact that league officers were not always available on a Saturday morning to read their e-mails and relied on retrieving messages about postponements remotely by telephoning, notifications of postponements must be telephoned to the relevant officers and not sent by e-mail. Clubs are also reminded that notifications to the Hon. Results Secretary should be made to the results line on 01206 381 535 as he is unable to answer two phones at the same time.
