**HALF YEARLY MEETING**

The Half-Yearly All Clubs Meeting will be taking place at Old Chelmsfordians on Thursday 05 January 2012, The Hon. Secretary will be sending out details nearer the date. Should prevailing weather conditions mean that this meeting is postponed, a notice to that effect will be posted on the web site as soon as any such decision has been taken. This information will also be available on the Leagues Facebook page and be posted on Twitter.

**CANNING TOWN PITCH**

Work upgrading the running track and pitch at the Terence McMillan Stadium that was due to be completed by the end of November will not now be completed until well into the New Year. It has therefore been agreed that until further notice Canning Towns first team will play their away fixtures on the grounds of their opponents. Where this occurs Canning Town will be liable for paying all of the officials and making all the calls associated with hosting a fixture.

**RULE CHANGES**

Any clubs wishing to put forward changes to the current rules **MUST** do so in writing to the Hon. Secretary **BY 01 FEBRUARY 2012**. Proposed rule changes will then be circulated to all clubs by 15 February 2012 and any amendments to these proposals must be submitted to the Hon. Secretary by 28 February 2012. Proposed rule changes will then be sent to the Essex County F.A. for approval and those that are approved will be put to the A.G.M. in June.

Should any other persons, apart from the club representatives already on the Committee, wish to stand for election as a club representative, details of the procedure for doing so are contained in League Rule 4 (B). Should it transpire that there are more than eight nominations, including those standing for re-election, then a ballot will take place at the Annual General Meeting.

**PLAYER REGISTRATION**

A list of players registered with a club is shown on the Full Time page beneath the name of clubs for ALL forthcoming fixtures. If you have sent a registration form to the Registration Secretary and the players name does not appear in the list, you must contact the Registration Secretary before he plays.

There is no excuse for any clubs to play an unregistered players in a match.
