REGISTRATION SECRETARY ZONE A

ENTERING RESULTS SHEETS ONTO FULL TIME

All clubs will have received an e-mail inviting them to enter their result sheets directly onto the full time system instead of using the spreadsheets. This system is far simpler as all the basic match information is already on the system and it is just a matter of ticking boxes and entering the goals scored by each player. Whilst voluntary at this stage, this system will become mandatory from the start of next season.

Access for clubs will start on 05 November and all clubs wishing to use this method should contact Peter Godfrey with the full name and e-mail address of each person in their club who will be entering this information. He will then allocate each of them a Username and Password.

FINES (from the Hon Secretary)

There were a lot of fines sent out last month.
The bulk of these fines were for:

- Late phoning results
- Not giving all goalscorers
- No tea for the ref

The rules around reporting results and goalscorers for League & League Cup matches should be well known to you all. Clubs are also picking up fines for these offences when playing County cup matches.

Please read page 48 of the handbook which details your responsibilities. I have pointed this out after the last round of the County Cup but with another round this Saturday it is worth pointing out again. Please make sure all Managers know this so we can cut down on fines.

No tea for Referee - Rule 10 (B) 'Refreshment for Match Officials must be provided by the home Club at full time unless these are declined before the game.'

Please make sure your Club complies with this rule. The League sends out a lot of fines for not doing this every season. Apart from anything else we should have respect for the match officials and make sure they get a drink.

REGISTRATION CHECKS

When a Registration Check is held at one of your matches, clubs are requested to tell their players that when they are asked to sign the Registration Check form they should sign it in the same manner as they signed their Registration Form and not do some shorthand swiggle. These unannounced Registration checks are important if we are to curb the playing of unregistered players.
