**F.A. INTER LEAGUE CUP**

Our First Round tie against the Herts Senior County League, who beat the Middlesex County League 5 – 4 on penalties in the Preliminary Round, will take place on Saturday 08 October at A.F.C. Hornchurch K.O. 3:00 pm. Teams with players in the squad have, as has been customary in the past, had their League matches postponed. Your support at this match would be very much appreciated.

**NOTE TO REFEREES**

There are some weeks when the fixture list comprises mainly of County Cup matches. Whilst you may not have been given an appointment at the moment this may change as referees are taken off matches by the County F.A. to cover these County Matches.

The league are using a new Referees Result Sheet this season and copies have been sent to all referees by e-mail. A copy is also available on the league web site. Please do not use the old sheets.

When filling in Result Sheets please put down the name of Assistants provided by clubs even if there is more than one. Will you also ensure that you fully complete the sheets..

Referees are requested to ensure that if they take disciplinary action against a player and are then subjected to abuse by that player, they ensure they report it to the County who will then take further action against the player. The League do not want its Referees to have to put up with disrespect of this nature and the only way we are going to stamp it out is if Referees report it and give the County F.A. ammunition to give these players a long suspension.

**NOTES FROM THE HON. SECRETARY**

**Registration Forms**

All Clubs should know that registration forms of any description should go to the Registration Secretaries either ZONE A - Dave Bloxham or ZONE B - Phil Coulthard. No one should be sending them to myself or any other League Officer.

**Discipline & Respect**

Most Clubs appear to understand the need to maintain good discipline and respect for the opposition and match officials. There are however a few cases that are causing the League some concern. Poor behaviour is unacceptable to the League and it is up to the Clubs concerned to put this right. Failure to do so could ultimately result in expulsion.

**Suspended Players**

There have been a number of incidents this season and last where Clubs have played players who are suspended either through the sine die suspension list or because of a suspension picked up for a Sunday team etc. Unfortunately players are not good at remembering their suspensions which makes life difficult for Clubs.

However, the rules on this are very clear.

It is the **Clubs** responsibility to ensure that when signing players on they are eligible to play, the Club must carry out all necessary checks. The player signs the form confirming that all his obligations with his previous Clubs have been cleared and also declares he is eligible to play under FIFA and FA rules.

**Responding To ECFA Fines**

Some Clubs have commented that the response time to fines had been reduced this season. I have written to the ECFA and this is the answer.

The FA had decided to amend the procedures to only give clubs only 7 days to respond to ECFA fines, as the cases are matters of fact. The FA have now decided that from the end of last week for all Cautions the time will be increased back to 14 days, and the ECFA have queried if this should not also be the case for send offs

If there are any problems, Club's should get in contact with the ECFA who will see what they can do to assist with getting their paperwork in.
